Re: Brownfield Clean-up Grant Application & Match

Request by the Economic Development Director to have the Council approve an application to the U.S. Environmental Protection Agency for \$200,000 in grant funding to remediate contamination at 45 Front Street, and to commit cash matching funds in the amount of \$40,000 for that grant application.

The City of Belfast had previously authorized environmental assessments to be performed on the land and buildings located at 45 Front Street (also referred to as the Maskers' Property), through the City's Brownfields Assessment Program. Phase I (document) and Phase II (sampling) environmental assessments, which included a Hazardous Materials Inventory (for building materials) have been essentially completed, and a preliminary Analysis of Brownfield Cleanup Alternatives has been drafted. Most recent estimates for the cleanup costs for this property (both land and buildings) are in the neighborhood of \$230,000.

The U.S. Environmental Protection Agency (EPA) makes grant funds available each year to units of government to pay for cleanup costs on properties that they own, up to \$200,000 per parcel. Applications are due to the EPA on January 22<sup>nd</sup>, and awards are announced during the summer. Recipients have three years to use these funds. All other things being equal, a site that has been properly assessed and remediated will be more attractive for (re)development in the future.

These grants require a 20% match, but units of government can also apply for a waiver of that match. Staff recommends that the City apply for the maximum grant of \$200,000, and to commit cash match in the amount of \$40,000, even though the City may pursue a waiver for that match.

The City of Belfast is applying for a U.S. EPA Brownfields Cleanup Grant for funding proposed remediation activities at the Masker's Theater & Thompson's Wharf Site located at 45 Front Street in Belfast, Maine. The application will be submitted to the U.S. EPA on or before January 22, 2014. The proposed remediation will likely include the abatement and/or removal of asbestos, lead-based paint, other potential hazardous building materials, and contaminated soil.
